COMPANY OVERVIEW

Gabon Special Economic Zone (GSEZ) was established as a result of a **Public-Private Partnership (PPP)** between Arise IIP and the Gabonese Republic, represented by the CDC (Caisse des Dépôts et Consignations), formalized in March 2010. GSEZ provides a range of services to its clients, including land leasing and operations & maintenance, while also focusing on the sustainable management of its forests to meet the needs of its customers with timber.

The zone offers **a unique administrative and fiscal framework**, which facilitates the establishment of both local and international investors. This allows businesses to easily set up operations in the zone, benefiting from an efficient setup process.

GSEZ is divided into **three key areas: industrial, commercial, and residential.** The Nkok Special Investment Zone, located 27 km from Libreville, Gabon's capital, is easily accessible via road, rail, and river transport. It also features a multimodal logistics hub, which includes barge-handling facilities directly connected to the port of Owendo, ensuring smooth logistics for businesses operating within the zone.

OUR SUSTAINABLE BUSINESS MODEL

Our business operations are anchored on the Special Investment Zone (SIZ) model, with **four zones launched between 2010 and 2022.** This model fosters sustainable growth by combining commercial viability with inclusive and climate-resilient industrialisation. Our industrial zones are conceptualized and built around **3 key elements.**

- 1. We carefully select our investors to mitigate reputational risks; actively excluding illegal sectors such as weapons and ammunition manufacturing
- Adherence to the highest level of environmental and social corporate governance standards and compliance
- 3. Promoting inclusive growth through linkages and spillovers

Our Industrial Zones



Launched in 2010, this was the first SIZ to launch in Gabon. It is a multi-sectoral industrial park located 27 km from Libreville. Sitting on 1126 ha of land, it includes an industrial, commercial, and residential zone. The SIZ brings together +130 companies from 17 countries operating in 22 industrial sectors, including a cluster dedicated to wood processing, which brings together 88 companies.



This econnomic zone, launched in june 2021, consists of a developed area of 318 ha and a harvestable area of 522 ha. The zone's infrastructure is rapidly evolving. Owing to its single window clearance system, local and international investors can easily set up units. The zone's composition includes industrial, infrastructural and residential spaces and multiple quays.



Created in May 2022, this is an industrial zone specialising in wood transformation. With a total area of 1432.5 ha, the zone includes a cluster dedicated to wood processing.



Created in 2018, this industrial zone specialises in wood transformation with a total area of 900 ha.

OUR OTHER INDUSTRIES

Pharmaceutical Industry



La Sante Pharmaceutique is the first pharmaceutical factory in the CEMAC region, specializing in the production of generic drugs (tablets, capsules, ointments, and syrups).

Metal Waste Recycling



La Chaudronnerie Du Gabon is one of the first factories to be set up in Nkok SIZ. It is specialized in the recycling of metals to produce reinforcing steel for the local market.



Les Acieries Du Gabon contribute to the creation of jobs by buying waste metals parts from the city to produce reinforcing steel that meets international standards.

Plastic Recycling



Jia Ming Plactics Manufacturing recycles plastic bottles to produce packing straps used to export wood products.

Charcoal



Huaxing Environnement produces activated charcoal from wood waste residues. The end-product is then used for water filtration, cosmetics, and pharmaceutical industries.

Cement



African Cement is current the only operator to produce clinker-based cement in the area for national and international use.

Wood Glue



Windson resins and chemical is the first formaldeyde and resin plant in the CEMAC region. This company specializes in formaldehyde and resin production, glue used to produce plywood.

Gold



ROG- Raffinerie Gabonaise de l'or is the first gold refinery in Gabon and Central Africa, specializing in the marketing, purchase, sale, export and processing of gold (1st, 2nd and 3rd phases).

Other Companies



The Gabonese Agency for Spatial Studies and Observations is a parastatal agency whose role is to monitor the national territory through satellite data, mainly monitoring the forest cover.



CIMFEP, the International Multisectoral Center for Training and Vocational Education of Nkok, with a capacity of 1,000 students, was built to compensate the need for manpower in the following sector areas: wood, boiler making, welding, mechanics, scrap metal, electromechanical, etc.



The second training center offers courses in Technologies of Information and Communications.

PRODUCTS

With contributions from 144 companies, the Nkok SEZ offers a diverse range of products, including pharmaceuticals, metals, plastics, charcoal, gold, and wood glue. However, wood transformation remains the cornerstone of activities in our industrial zones.

WOOD TRANSFORMATION

Gabon is a global leader in the timber industry, with 88% of the country covered by forests and 12.5 million hectares of sustainably managed forests, home to over 1500 tree species, including the renowned Kevazingo and Okoumé. The wood industry plays a pivotal role in Gabon's economy, and GSEZ is a key player with its own log supply chain that supports various wood processing businesses. Around 28 logging companies supply 63,000 m³ of logs monthly (a total of 750,000 m³ on average), stored in a vast 22-hectare log park.

Within the Nkok Special Economic Zone (SEZ), wood processing is at the heart of operations, with 60 companies specializing in various stages of the timber transformation process, fostering synergies across industries. Each type of wood processing contributes to creating high-quality products while maintaining sustainable practices. The types of wood processing include:

Sawn timber



Companies in this sector operates in the **first transformation** of wood; which involves the cutting of timber into various shapes including planks and boards. Within the Nkok SEZ, several of these companies comply with the international 'Chain of Custody Standard FSC-STD-40-004,' ensuring that their operations align with responsible and sustainable forestry practices. This enhances traceability and sustainability throughout the supply chain.

Veneer sheets



Veneer sheets are produced through the **second transformation** of wood. This process involves peeling thin layers of wood from logs, which are then used in furniture, paneling, and other decorative applications. In GSEZ, companies specialize in producing high-quality veneer sheets, often made from valuable species like Okoumé, which is highly sought after for its fine grain and appearance.

Particle board



This is an engineered wood product made from wood chips, sawdust, and other wood residues. Our particle board factory uses this ecological resources to create A-class particle boards. Those products from the **second transformation** of the timber significantly impact both climate and economy, saving an average of 30,000 tonnes of CO₂ annually by making use of what would otherwise be waste material.

Plywood



Plywood production involves gluing together multiple veneer sheets, with each layer arranged with the grain at right angles to the adjacent layer. Gabon is recognized for its luxury plywood, particularly made from Okoumé. This product obtained after the **third transformation** of the timber is known for its durability, strength, and aesthetic qualities, making it ideal for high-end construction and furniture.

Wood furniture



A group of small and medium-sized enterprises (SMEs) manufactures 100% Gabon-made furniture from rare species, showcasing the craftsmanship and value addition in the local wood industry, producing high-quality **third transformation** furniture. The furniture industry in GSEZ showcases local expertise and contributes to economic growth and job creation.





ENVIROMENTAL SUSTAINABILITY

We follow processes throughout the lifecycle of our timber products to minimize the environmental and social impacts from the forest inventory stage, till its end use. We have a widely communicated supply chain policy to ensure this is achieved. Ensuring a high level of commitment to our supply chain policy and systematically monitoring progress is our priority. We actively and consciously source and procure our timber products for our operations in an ethical, responsible, and socially conscious manner.



GSEZ IS CERTIFIED BY THE FOREST STEWARDSHIP COUNCIL® (FSC)

Sourcing wood from responsibly managed forests is a fundamental requirement for the timber industry. We recognize the significant role that certification plays in promoting sustainable industrialization and it is a crucial part of an efficient value chain that runs parallel to downstream sourcing, production, economic, and marketing activities. The upstream forest certification process ensures the responsible sourcing of raw timber used in production, while downstream processes bring the finished products to end customers. Committed to this principle, we ensure that our operations comply with the highest standards, including the FSC® certification (FSC-C149179) and have implemented them at different levels of our value chain-

OUR LEVELS OF CERTIFICATION

Forest



At the forest level, we implement **FSC Forest Management standards**, which guarantee that our forestry operations maintain biodiversity, uphold ecosystem integrity, and ensure responsible timber harvesting practices. This certification requires compliance with legal requirements, respect for indigenous rights, and strict environmental safeguards to ensure responsible harvesting and forest regeneration.

At these two levels, GSEZ has acquired **Chain of Custody (CoC) certification** which **ensures traceability through each step** starting from the forest.

This certification guarantees that wood materials transported and processed within our facilities, such as veneer, plywood, and particle boards, are derived from sustainably managed forests. By tracking each step, we maintain transparency and prevent the mixing of certified and non-certified wood, ensuring that all products are ethically sourced and produced in line with global sustainability standards.

This holistic approach to certification underscores GSEZ's dedication to promoting responsible pratices across all phases of our operations, from forest management to final production.





FOREST CERTIFICATION

At GSEZ, our commitment to responsible forest management is demonstrated through our active pursuit of forest certification. Between 2021 and 2022, we successfully certified **520,257 hectares** of forest under the FSC standards, followed by an additional **397,580 hectares in 2023-2024.** These certifications are a testament to our ongoing efforts to preserve biodiversity, responsibly manage forest resources, and contribute to the global fight against deforestation. We are dedicated to expanding this initiative and remain steadfast in ensuring that our forest operations meet the highest standards of sustainability and environmental stewardship.

INDUSTRIAL UNITS FSC CERTIFICATION

In GSEZ, companies adhering to the FSC Chain of Custody Standard (FSC-STD-40-004) ensure that the wood processed **originates from responsibly managed forests.** Since the certification of the first two companies under the FSC CoC standard in 2019, the number of certified companies within the Nkok SIZ has been growing. Today, the SIZ comprises **+10 certified companies**, with additional businesses actively working toward certification.

TRACEABILITY AND DUE DILIGENCE IN OUR SUPPLY CHAIN

TRACEABILITY

Traceability is the ability to **trace the history and journey of wood products passing through the supply chain**, and to help in assessing and **verifying that the products come from legal sources.** [ASEAN (2012), D. Louppe (2015) and FAO (2016)].

We ensure the traceability of all our products and services, reflecting our commitment to meeting the demands of the market and building trust.

OUR EFFORTS

Log tracing begins at the forest level, starting with the inventory stage. This process continues through tagging, harvesting, log cutting, skidding and finally to the storage park.

At the logistics stage, we ensure a declaration of the logs loaded onto wagons and trucks is made and approval received. This stage also includes the transportation permit and log list invoice. By meticulously monitoring our suppliers and tracing the wood's journey from the forest to our logyard, we maintain and enhance the traceability of our products.



DUE DILIGENCE IN SUPPLY CHAIN

Risk Management in Supply Chain

Achieving sustainable supply chain management critically hinges on effective risk management. Given supply chains' complexity and vulnerability to external and internal risks, a robust risk management strategy is essential. Such a strategy enables businesses to identify and mitigate potential disruptions, thereby minimizing their adverse impact on sustainability.

To support this, we have a Due Diligence System, ensuring transparency throughout the supply chain. This ensures:

- 1. The wood we source is legally harvested
- 2. We do not violate traditional or civil rights
- 3. We have transparency in our chain of custody
- 4. We have verified documentation to substantiate legality

NKOK'S SEZ: THE FIRST CARBON- NEUTRAL INDUSTRIAL ZONE IN AFRICA

This initiative aligns with global imperatives towards reducing carbon emissions and promoting green energy. As industries worldwide strive to minimize their environmental impact, the Nkok SIZ in Gabon stands out as a pioneering example of integrating carbon-neutral policies within a robust industrial framework and represents a groundbreaking achievement in sustainable industrial development as Africa's first-ever ISO 14064-1 carbon-neutral industrial zone.

This certification provides a transparent third-party assessment of GSEZ's carbon footprint and offsetting, as we aim to be a model of 'Sustainability in Action'.

Through **deliberate action and proactive initiatives aimed at minimizing our carbon footprint,** we have made notable progress toward sustainability and reached the following key carbon accomplishments also contributing to the UN SDGs:



Greenhouse gas emissions measured and managed.



An average of 30,000 tCO₂ saved per year by converting wood waste into particle board.



Approx. 50,000 tCO₂ diverted from being emitted in the atmosphere via **our biochar** manufacturing facility.



Decarbonization of transport with the opening of the multimodal logistics area in 2023, saving around 15 kg of CO₂ per container shipped.



Blue carbon initiatives. In situ: 100 hectares of mangroves conserved (approx.10% of the industrial zone land area) + 30,000 tCO₂ sequestered per year. Ex situ: Mangroves restoration project with government and communities of Akanda covering approx. 1,000 hectares of endangered mangroves.



7,000 tons of **plastic collected and recycled** in Nkok SIZ since 2019, (~210 millions of plastic bottles removed).

OUR CIRCULAR ECONOMY INITIATIVES

A circular economy is where **used products or parts are returned or processed** so they can be repaired, resold, refurbished or recycled. This thereby reduces the waste accumulated after processing. By recycling materials, we prevent them from ending up in landfills and we create jobs. GSEZ has set up a number of circular economy initiatives for the sustainable and responsible management of our resources:

Recycling Scrap Metal into Reinforcing Steel:

These companies are specialized in recycling processes where scrap metal is transformed into reinforcing steel that meets international standards for the local market.

Turning Used Plastics into Packaging Straps:

This recycling initiative focuses on transforming discarded plastic bottles into packaging straps used for securing wood products. Notably, an approximately **USD 3 million has been invested in Jia Ming Plastics, the first plastic recycling plant in Gabon,** with a monthly recycling capacity of 40 tons of plastic waste.

Wood Waste into Particle Boards:

This initiative has been launched by GSEZ, to optimize the amount of material our timber business reuses and recycles to meet our circular economy waste management philosophy. Our particle boards industry alone **prevents the emission of an estimated 30,000 tons of CO₂ annually.**

Converting Wood Waste into Activated Charcoal:

Sawing waste from various operators is repurposed into activated and non-activated charcoal, which is then distributed to industries such as cosmetics, pharmaceuticals, and heavy manufacturing.





PROMOTING RESPONSIBLE FOREST OPERATIONS



40% of the logs getting into our special economic zone are sourced from our own responsibly managed forests. GSEZ is committed to the implementation of responsible forest management. GSEZ acknowledges that responsible management implies the maintenance of the productivity of the asset base. We strive to ensure our forest exploitation techniques allow us to meet the needs of the present without compromising the continuity of the ecosystem and the goods and services it provides. We have adopted the Reduced Impact Logging techniques that result in significantly less damage to the forest and ecosystem. Reduced Impact Logging (RIL) involves the following key practical measures we adhere to:

We prepare a pre-harvest inventory.

Before harvest, we develop a pre-harvest plan of roads, skid trails, and landings to provide access to the harvest area and to the individual trees scheduled for harvest while minimizing soil disturbance and protecting streams and waterways with appropriate crossings. We follow appropriate felling and bucking techniques, including controlled felling, cutting stumps low to the ground to avoid waste, and optimal cross cutting of tree stems into logs to maximize the recovery of useful wood.

We construct roads, landings, and skid trails, adhering to engineering and environmental design guidelines. We winch logs to planned skid trails and ensure that skidding machines always remain on the skid trails.

We conduct postharvest assessments to provide feedback that guides us in evaluating the degree to which RIL guidelines were applied successfully.

WORKFORCE SAFETY AND WELL-BEING

Operating a timber value chain in a sustainable manner calls for an intentional provision of a safe environment for all workers. Fostering workers' well-being and promoting a safe environment, free from injuries have positive impacts on business productivity and costs.

Our Approach

GSEZ has established policies, including the **Occupational Health and Safety Policy,** to ensure a safe and healthy working environment for their employees, contractors, and visitors. Our policy is fully aligned with Gabon's environmental laws, reinforcing our commitment to responsible governance and sustainable practices. In addition, we also uphold a Social Policy aimed at promoting employee well-being, inclusion, and rights.

Our commitment to creating a healthy and safe working environment spans the entire value chain, from forest operations to office-based activities. This includes proactive measures to mitigate safety risks by establishing a dedicated Safety Department, responsible for integrating proper design, engineering, and preventive maintenance strategies across all areas of our operations—from forest management to the Nkok SEZ. Furthermore, our Social Policy emphasizes employee welfare, supporting diverse initiatives and events to ensure the well-being of our workforce.

Examples of Health and Safety Initiatives:

65% Reduction in Injuries: In 2023, we achieved a 65% reduction in the reported injury rate from our 2022 baseline, demonstrating significant improvements in workplace safety.

Safety Signage: We installed safety signs and informations across all our forest sites with over 50 signs installed in the Nkok SIZ alone to raise awareness and enforce safety protocols.

Road Safety: More than 17 speed breakers were installed to enhance road safety in our areas of operation in Nkok.

Examples of Employee Well-being Initiatives:

Cancer awareness workshops: We conducted awareness events about cancers affecting both women (such as breast and cervical cancers) and men (such as prostate cancer) to promote health education among employees.

Menstrual Leave: Female employees are entitled to one menstrual leave day per month.

Social Support: We provide social subsidies to employees during significant life events such as marriages, births, and deaths.

Employee Feedback and Grievances: Every forest site is equipped with a complaints and grievances logbook, ensuring employee concerns are documented and addressed. Similarly for all GSEZ's employees outside our forest sites, ethics committees are established that handle complaints received at managerial or HR levels.

Sports and Wellness: Regular weekend workouts and other sports events are organized to encourage physical fitness and team bonding.



CAPACITY BUILDING

At GSEZ, we recognise that being a learning organisation is crucial to successfully navigating the competitive and complex landscape of today's world. To meet the challenges ahead, we are committed to continuously enhancing our learning and development offerings. 
THE LOCAL DEVELOPMENT FUND (LDF)

Gabon has a ministerial order that requires all forest company operators to contribute to the economic development of the communities that are directly or indirectly impacted by their forest operations. Each company adheres to this directive known as the Local Development Fund (LDF). GSEZ complies with this legislation and takes appropriate initiatives to improve the well-being of the local communities and society at large.

LDF support

As per the Gabon regulatory requirement provided by the Forest ministry, each log harvested earns the community 800 CFA per cubic metre. The higher the production, the higher the LDF allocation.


